a. VALLEY MAINTENANCE

There were seven locates completed. New sewer taps were inspected at 4010 W. Latonka Road, S. Hawthorne Street and S. Layton Avenue.

____7. Scott reported that they had an incident at the lift station on January 31, 2024. A component on one of the pumps broke and sprayed waste water over the entire room. The control systems failed and the by-pass pump started pushing the waste into the overflow tanks. The Platte Canyon employees were onsite when the incident happened. Brown Hill Engineering and Controls was called to begin repairs. Platte Canyon employees had to stay on duty at the lift station 24 hours a day for 3 days. The components were replaced and two additional components were ordered. A claim will be filed with the insurance company.

Phyllis asked if other lift stations have these problems or if there was a problem with the design, Scott said they will be bringing the companies that designed and built the lift station together to work out the problems. Phyllis said the plan to bring the companies together is a good plan and suggested it be done as soon as possible. Cynthia thinks the problem is likely a programming and logistics issue. Vince asked if the rates with the insurance company would raise if Valley Sanitation files an insurance claim. Cynthia said she didn't think it would and she will be talking to the insurance pool to determine if the incident can be covered and what the decutible might be.

2. Sewer Lining Project: The Valley capital project is being done currently, the lining of sewer pipe at the golf course. There are six sections of pipe and two have been completed. The other four are scheduled for next week. When that is done, a company called Specter Shield will spray the manholes, sealing up the manholes to prevent water and other intrusions. Inliner is a very responsive company and working with the golf course and Platte Canyon is expecting very little potential remediation of the grass.

Phyllis asked if the pipe was bad. Cynthia said the pipe was really bad and the company had to dig down to repair the pipe before lining it.

3. Year-End Financial Report: Cynthia explained the year-end financials for 2023 which are still going through audit. The end result for the district is that there is \$1,265,818.58 cash on-hand leaving the district in a very healthy position. Chris asked about the loan balance which will show in the audit. Chris asked if the loan balance for the lift station could be shown in the Schedule of Revenues and Expenditures. Cynthia said that could be done and she will talk to Vanessa about how best to show that information.

There was no further business and the meeting was adjourned at 6:00 PM. The next meeting will be Wednesday, March 13, 2024, at 5:00 pm, at the Platte Canyon Water and Sanitation, 8739 W. Bowles Avenue, Littleton, CO.
