a. VALLEY MAINTENANCE - Scott Hand

(1) December

There were eight locates completed. One new sewer tap was inspected at 3386 W. Wagon Wheel Drive. The lift station was 200 hours over the projected man hours. There was one pump plugged up and a power fail that triggered the generator.

Scott reported that the new equipment for chemical root cutting is now available and staff is being trained. Platte Canyon has a large stockpile of chemicals for doing the root work.

__7. Capital Project: Cynthia reported that now that the service fee has been increased and the funding is now available, the capital project of relocating the last segment of the Oxford landfill can begin. Cynthia presented the contract with standard contract language to move forward with the project for \$270,000. Tim Flynn has reviewed the contract and the constructio company has been given notice to proceed. The budgeted amount for the project is \$340,000 with another \$40,000 for contingencies.

MOTION: Chris Dye made a motion to approve the contract with Diaz Construction for the capital project of relocating the last segment of the Oxford landfill. The motion was seconded by Vince Leone and passed.

- __8. Sheridan #1: The City of Sheridan along with the developers and Cynthia Lane met on the project at the Bonsai location and everything is worked out in terms of the process. Sheridan #1 is going to engage Valley Sanitation via Cynthia, Tony Cocozzella and Justin Roquemore to do a technical review of the components of the project that are subject to Sheridan #1 review. Cynthia confirmed with the developer that if they go forward with the project they have to pay \$1,000 per unit for a total of \$150,000 as the system development charge. It is expected that the charge will be paid late this year or early next year. The developer will be closing on the property in two weeks. In addition, Sheridan #1 and the City of Sheridan are paying for a full rehab of the Sheridan #1 sewer system and is being paid for by the developer and the city. Part of the Sheridan rehab of the system has to be approved by the state. It will probably be a year before they break ground on the work with some utility work done before that.
- __9. Board Election Forms for Vince Leone and Chris Dye need to be submitted for their reelection.

There was no further business and the meeting was adjourned at 6:00 PM. The next meeting will be Wednesday, February 8, 2023, at 5:00 pm, at Platte Canyon Water and Sanitation, 8739 W. Bowles Avenue, Littleton, CO.
