\_\_\_\_7. Financial Report: Cynthia said there is no update on the financials. Vanessa is getting the final invoices this week and she'll mail those at the end of the month. We'll review those at the February meeting along with January financials and year-end financials. In January Valley Sanitation will receive the service charge revenue from Englewood which is backdated to 2024. With those completed, Vanessa will be email to the board.

\_\_\_8. Action Item: It was decided to change the meeting time from 5:00 pm to 4:00 pm starting in February.

\_\_\_9. Board Election Forms: Cynthia provided the new election forms that need to be signed by each of the candidates for the May 2025 election. The candidates for re-election are Mary Alice Ledbetter and Phyllia Gooden.

\_\_\_\_10. Resolution 2025-1-1:

MOTION: Chris Dye made a motion to approve Resolution 2025-1-1, A Resolution on Meetings of the Valley Sanitation District Board of Directors. Vince Leone seconded the motion and the motion passed.

\_\_11. Resolution 2025-1-2:

MOTION: Chris Dye made a motion to approve Resolution 2025-1-2, A Resolution Calling for the 2025 Regular District Election and Appointing a Designated Election Official. Vince Leone seconded the motion and the motion passed.

12. 2024 Audit: Cynthia explained details pertinent to the 2024 audit. Phyllis asked about several issues including Tax Detection Fraud, multiple levels of authority for check signing and how the TABOR amendment affects Valley Sanitation. Cynthia addressed Phyllis' questions and said that Vanessa Shipley ensures Valley Sanitation is in compliance with TABOR. The fee is \$5,600 for the audit.

MOTION: Vince Leone made a motion to approve the engagement letter with Shilling and Company for the 2024 audit. Chris Dye seconded the motion and the motion passed.

\_\_\_13. Denver Paving over Manholes: Cynthia said that Denver is using the Government Immunity Clause and will not be reimbursing Valley Sanitation for the paving work in December. Cynthia promised Denver if it happened again she would take the issue to City Council.

\_\_\_14. Need for New Board Member: With Vince Leone leaving the board in the next few months, the board will need to find someone for Vince's position.
