a. VALLEY MAINTENANCE

(1) October

7. Lift Station: Armando said lift station has not been having problems.

TV Inspections: 8,137 feet scheduled

There were two locates completed. Sewer tap inspection at 5420 S. Keenland Court and a customer service CTV inspection at 5415 S. Keenland Court.

- __8. Budget 2025: The proposed budget revenue is expected to be \$707,404 with proposed expenditures of \$563,876. Cynthia explained the different areas of the budget. There is no projection to raise the service fee 15%. Englewood is raising it's rates 4.5% which will be an increase of 4.5% in service revenue for Valley Sanitation. Vanessa will put together the resolutions
- __9. First Amendment to General Professional Engineering Services Agreement. The first amendment is an updated agreement with JMT for on-call services. JMT has a rate increase but Valley will only be affected if Valley Sanitation needs to use them.

MOTION: A motion was made by Vince Leone and seconded by Chris Dye to accept the First Amendment to General Professional Engineering Services Agreement. The motion passed.

__10. Flying Saucer: There is nothing to report. Armando said a lot of requests for soil studies have been made. Cynthia said because of the proximity to abandoned land fills the studies will determine if they need a full scale remediation. This is the Phase 1 assessment.

- __11. Sheridan Sanitation #2: Cynthia reported that Tim Flynn is being asked to do work on Sheridan Sanitation #2 Inclusion and Exclusion. This might come to the board for discussion in the next couple to months.
- __12. Sheridan Sanitation #1 Inclusion and Exclusion Agreement: The agreement was presented in November and the board decided to engage an outside attorney to review the agreement. Tom George, SpencerFane Law Firm, was recommended by Tim Flynn as an independent counsel attended the meeting to discuss the agreement and will report to the board in January. Tom George will send an Engagement Letter to Valley Sanitation which will engage Tom George as a special counsel charging on an hourly basis.

There was no further business and the meeting was adjourned at 6:00 PM. The next meeting will be Wednesday, December 11, 2024, at 5:00 pm, at the Platte Canyon Water and Sanitation, 8739 W. Coal Mine Avenue, Littleton, CO.
